ABOUT THE SANCTUARY



Thousands of children of all ages in our local community are victims of unthinkable abuse and neglect at the hands of those that are supposed to nurture, love and protect them.

When they are removed from their abusive environment, they experience extreme trauma and are then often placed into a broken government system that allows many foster parents to exploit them for financial gain. Due to the many shortfalls of the system, it is very common for children to experience **multiple placements**. These multiple placements can cause repeated trauma that manifests into emotional and psychological damage that is, oftentimes, irreversible.

A DIFFERENT KIND OF AGENCY

We are a different kind of Child Placing Agency. What makes us unique is that we are trained in Trauma-Informed Care and offer Wraparound services to our foster families, including 24/7 crisis intervention, counseling services for the foster children and families in our agency, and a fierce commitment to stand behind the children and families in our care. Our mission is simple. Once a child enters into our care, we make a commitment to work with that child towards healing until they are either returned to their families of origin or to permanency, such as adoption. We stop the cycle of multiple placements that so severely hurts the children in care. We need your help as we care for these vulnerable children and for the families who stand willing to fight for them.

OUR MISSION & VISION

Our mission is to achieve permanent sanctuary and healing homes for children and families from hard places.

Using TBRI (Trust-Based Rational Intervention), we will promote and achieve healing and permanency for at-risk children and families, and become the most respected, valued and effective Child Placing Agency (CPA) in Texas. Our children will not suffer any more. They will have permanent, loving homes and be healed. We will rally the community around our children and families to provide support so that every home can be successful. We will become a model for replication by other agencies.

We help children and families work toward healing and permanency. We stop the cycle of multiple placements that so severely hurts the children in care.

We wholeheartedly believe with TBRI (Trust-Based Relational Intervention), we have the tools to care for the foster children in our community. We know that every child - no matter the situation - can have the opportunity for healing and change.

We want to be the model for other child placing agencies across the state. We know how to stabilize placements for even the most challenging children in the system from pre-licensing training to post-placement support.

OUR GOALS

- Have the lowest “unfavorable discharge” rate of all child placing agencies in the State of Texas

- Provide healing environments in which the children in our care get better, as evidenced by the lowering of their therapeutic levels over time

- Recruit, train, and fully support high quality foster parents who share our vision and our level of commitment

- Provide evidence-based TBRI training to agency staff and foster parents

- Support our families and children through crisis management, therapy, and wraparound services

WRAPAROUND CARE



SUPPORT IS EVERYTHING.

Support is what sets us apart from other foster agencies. It is also what requires additional, ongoing funding beyond the government per diem. Being fully funded by generous donations from local businesses, churches, and individuals, we can provide unparalleled wraparound support to our foster families, helping them achieve healing and permanency for our kids and families from hard places. THERAPY & COUNSELING

We provide licensed counselors who are trained in TBRI (Trust-Based Relational Intervention), so that our families can have hope and real solutions to the challenges they face, especially for those caring for children with the most challenging behaviors. We strive to work together to provide counseling to the foster parents, the foster child, and the biological children in the home to ensure the stability and health of the placement

24-HOUR CRISIS INTERVENTION

Our foster families have access to 24-Hour Crisis Intervention, which includes real-time response to the home when needed. During the hours of business, a case manager and professional counseling staff work tirelessly to ensure the needs of the family and child are met. Outside of business hours, we have on-call staff ready to assist the family in their time of need.

RESPIRE & ALTERNATIVE CARE

Every parent needs a break; however, foster parents can't just call up a babysitter. We recruit and train teams of volunteers to help provide Respite Care (overnight, longer stays) as well as Alternative Care (babysitting) for our foster families. This part of the wraparound support ranges from keeping our foster children overnight to volunteers providing meals, providing essential items to our Partnering Foster Closet, and hosting events

COMMUNITY-BASED SUPPORT

We mobilize churches, businesses, and individuals to help meet the needs of our foster families, from giving financial support to providing physical needs. We have teams of volunteers who help host foster and adopt family events, provide meals, and meet materials needs. We also have individuals who step up to walk alongside a specific child as a mentor.
